“Governor Newsom Proclaims State of Emergency in Del Norte and Siskiyou Counties Due to Fires

Published: Aug 29, 2023

SACRAMENTO – Governor Gavin Newsom today proclaimed a state of emergency in Del Norte County due to the Smith River Complex fires and in Siskiyou County due to the Happy Camp Complex fires. The proclamations support the ongoing emergency response to the fires, which have destroyed homes, caused power outages, and driven the evacuation of residents.

Among other provisions, the proclamations waive certain licensing requirements and fees for out-of-state contractors and others working with California utilities to restore electricity. The proclamations also support impacted residents by easing access to unemployment benefits and waiving fees to replace driver’s licenses and records such as marriage and birth certificates.

GENERAL INFORMATION

EMERGENCY OPERATIONS CENTER: The City and County have been on a full activation of the Emergency Operations Center to support the Smith River Complex wildfires. Now that our team has secured generator power for most of the county, our updates will continue but not as often. Be assured, the public will receive any information that is relevant and if there are any evacuation or road closure changes, this information will be shared immediately. Please check on your neighbors!! If you or someone you know has an emergency, please call 911.

***FIRE INFORMATION: 75,775 acres. 7% containment. Over 2700 personnel are fighting these fires.*

***GOOD NEWS TODAY!! Governor Newsom has proclaimed a State of Emergency for Del Norte County.*

EVACUATIONS: Current evacuation levels:

LEVEL 3 (GO NOW) - From Slant Bridge to the Oregon border (including Gasquet, Patrick Creek, Little Jones Creek, Copper Creek Drainage, Cook Creek/16n19 17n07, Washington Flat, Pioneer Rd, Panther Flat Campground area, Sun Star Community, French Hill Road.

LEVEL 2 (GET SET) – Rowdy Creek Road from MM 3 (from Hwy 101) to MM 6, Rock Creek, Big Flat. (For Clarification, this does include the Boulder Creek, Paradise Flat and surrounding communities near Rock Creek) and LOW DIVIDE ROAD, from MM 1 to MM 13 (intersection of Low Divide Road and Rowdy Creek) This was previously a Level 3.

LEVEL 1 (BE READY) Hiouchi from Slant Bridge to east end of Hwy 197/North Bank Rd.

ROAD CLOSURES: Access to South Fork Road, Douglas Park and Howland Hill Rd is limited to residents only. This action is to ensure incident safety as fire personnel work in the area. This area of the forest is closed for all activities, including hunting, by Order 10-23-06 issued by the Forest Supervisor for the Six Rivers National Forest.

Hwy 199 is closed from Sunkist Road to Slant Bridge in Hiouchi, except for residents – currently, you can get through at Slant Bridge, with proof of residence.

ASSISTANCE: Many people have asked if there is assistance for generator fuel costs and spoiled food. What we know now is that your home insurance policy could be a source, but you would need to speak to your insurance carrier. If you received Calfresh benefits for the month of August, 2023 and lost perishable food items due to the current Smith River Complex fire, please contact the Department of Health and Human Services at 880 Northcrest Drive, Crescent City, or call 707-464-3191 to check for eligibility for replacement of lost Calfresh benefits.

*****PACIFIC POWER UPDATE: All power in the county has been restored with the exception of Gasquet & Patrick Creek areas that are still evacuated. Pacific Power has mobilized their large generators into Gasquet so that when it is safe to do so, they can start the process of re-energizing the community. The Office of Emergency Services is working with the Sheriff to coordinate when that time will be and the process in which Gasquet will move from an Evacuation Level 3 so that they can re-populate. Due to damage to some of the es, Pacific Power will***

need to make some repairs before restoring power to Patrick Creek residents. However, there is a plan to provide residential generators to those customers during this time until the substation can safely be powered. As you can imagine, a lot of coordination will take place in the coming days and we'll update you as soon as we know more.

***Generator power can sometimes fluctuate so prepare on the safe side of caution as to how much food you purchase until we are back to full power from the Pacific Power transmission lines. Pacific Power Customer Service: (888)-221-7070.*

***Del Norte Transfer Station – Due to poor air quality, the transfer station may close temporarily when necessary to protect their employees.*

***N-95 MASKS: During times of air quality risk, it's advised to stay inside and wear a N-95 mask should you need to be outside. Thanks to the DNUSD, N-95 masks are being made available to local businesses. You can pick up a small supply at the Chamber of Commerce office while supplies last.*

RED CROSS SHELTERS: American Red Cross has set up an emergency shelter for those affected by the fire at the Del Norte County Fairgrounds and at Rogue Community College in Grants Pass, Oregon.

Del Norte County Unified School District is distributing meals to kids 0-18, M-F only.

Neighbors helping Neighbors has food boxes to distribute to Hiouchi Residents Only. Call Hank @ 707-218-7250 to coordinate pickup.

Senior Center is open for lunch service (persons age 60 and older) Monday-Friday 11-12:30pm.

Brookings Community Helpers has gift cards and food boxes for those who have been evacuated. You must show proof of residency in Del Norte County. Supplies are limited. Please call 541-469-6988.

FREE MEALS -

In collaboration with Humboldt Area Foundation, Wild Rivers Community Foundation and the Del Norte Unified School District's Nutrition Services, additional meals are being provided for free to students and residents of all ages. From August 28, 2023 to September 1, 2023, each person will receive one bag containing breakfast and lunch for the day. You must be present to pick up your meal from 11 am – 12 pm.
